Sons of Thomas in Buckingham Co VA records

Thomas Henry, son of Thomas, first shows up in Buckingham Co, on the personal property tax list of 1823, as 1 tythe (age 21). By 1824, he had a horse and a mercants license, and in 1925, had added another horse, 5 slaves, and a gig. 1826 shows 2 additional horses, and by 1827, he has added another slave and 44 acres of land on Wolf Creek. By 1828, the year of his uncle Henry's death, Thomas Henry was listed with with 5 horses, 9 slaves, and 1 gig.

In 1829, Thomas Henry is shown with 2 tythes and an extra horse, which probaply accounts for the presence of his brother, John Jefferson Flood, who was in Buckingham Co, for his marriage to Frances Hogatt Russell, on Sept 29th of that year. The next year, John Jefferson is listed under his own name, with 1 thythe. The newly married couple soon moved to Missouri.

In 1830, thomas Henry received land "by terms of Henry Flood's will". His Uncle Henry left him 102 acres on Fish-Pond Creek, and 229 Acres on Wolf Creek, which Henry had acquired in 1825.

WILSON CO TENN COURT MINUTES 1816-1819

BENJAMIN BOWERS VS GEORGE MICHIE & WIFE:

ON THE PETITION OF BENJAMIN BOWER, WHO WAS SECURITY FOR JUDITH FLOOD (WHO HAS SINCE INTERMARRIED WITH GEORGE MICHIE) FOR THE GUARTIANSHIP OF ELIZABETH, ROBERT, HENRY, LUCY, AND JOHN FLOOD, MINOR HEIRS OF THOMAS, SETTING FORTH THAT HE IS LIKELY TO SUSTAIN DAMAGE BY AN IMPROPER MANAGEMENT OF THE ESTATE OF SAID MINOR HEIRS, AND THE SAID GEORGE MICHIE, BEING IN COURT, AND ASSENTING THERETO, IT IS ORDERED BY THE COURT THAT THE SAID BENJAMIN BOWERS BE DISCHARGED FROM HIS LIABILITY AS SECURITY FOR SAID DEFENDANTS, AND THEREUPON, GEORGE MICHIE IS APPOINTED GUARDIAN OF SAID MINOR HEIRS, AND ENTERED INTO BOND WITH JAMES CROSS, ABNER WASSON, WILLIAM MICHIE AND JAMES MICHIE, HIS SECURITIES IN THE PENALTY OF \$5,000 CONDITIONED AS THE LAW DIRECTS.
